Said proposals for the furnishing of all labor and materials for the construction, complete in-place, of the following, but not limited to, approximate quantities:

The provisions of Minn. Stat. 16C.285 Responsible Contractor are imposed as a requirement of this contract. All bidders and persons or companies providing a response/submission to the Advertisement for Bids/RFP of the City shall comply with the provisions of the statute.

No bids will be considered unless sealed and filed with the City Administrator of Monticello and accompanied by a cash deposit, cashier's check, or certified check, or bid bond made payable to the City of Monticello for five percent (5%) of the amount bid, to be forfeited as liquidated damages in the event that the bid be accepted and the bidder fail to enter promptly into a written contract and furnish the required bond.

No bids may be withdrawn for a period of 60 days from the date of opening of bids. The City of Monticello reserves the right to reject any or all bids.
