

2020 POND MAINTENANCE PROJECT

NOTICE IS HEREBY GIVEN that bids for the construction of 2020 Pond Maintenance Project will be received on-line through QuestCDN vBid™ until Thursday, November 5, 2020 at 10:00 a.m., local time. Bid results will be available at www.questcdn.com.

In response to the Governor's Executive Order #20-02 and City of Golden Valley's Declaration of Local Emergency in Response to COVID-19 Pandemic, Golden Valley City Hall is closed to the public. Pursuant to the authority granted by the March 16, 2020 Proclamation Declaring a Local Emergency, issued by the Golden Valley Mayor and adopted by the City Council on March 17, 2020, the City will hold the bid opening for the 2020 Pond Maintenance Project virtually by WebEx on Thursday November 5, 2020 at 1:00 pm. Holding the bid opening by WebEx will allow the process to take place publicly, while also complying with recent guidance from Governor Walz, the CDC and the WHO to practice social distancing and refrain from gathering in groups of more than 10. Instructions to access the WebEx meeting will be available on QuestCDN.com, emailed to plan holders signed in to QuestCDN.com, and available on the City website under the Bids & Quotes tab in the Quick Links box located on the left side of the webpage. The meeting will be accessible using a computer or telephone.

The Project includes the furnishing of all labor and materials for the construction complete in-place, of the following approximate quantities:

0.3	ACRE	GRUBBING
1,200	CY	COMMON EXCAVATION (LV)
2,150	TON	POND EXCAVATION (SPECIAL)

The provisions of MINN. STAT. 16C.285 Responsible Contractor are imposed as a requirement of this contract. All bidders and persons or companies providing a response/submission to the Advertisement for Bids of the City of Golden Valley shall comply with the provisions of the statute.

Bids will only be accepted via the electronic bidding service through QuestCDN.

The City Council reserves the right to reject any and all bids and to waive any bids received without explanation. No bid may be withdrawn for a period of 60 days.
